

## Registration Application for Band Councils, Tribal Councils or Band-Empowered Entities

### Program for Administering the Fuel Tax Exemption for Indians

This form is intended for any band council, tribal council or band-empowered entity (hereinafter "the applicant") that wishes to apply for the Attestation d'inscription (registration card) required to benefit from the Program for Administering the Fuel Tax Exemption for Indians. The program was introduced so that Indians, band councils, tribal councils and band-empowered entities can purchase fuel on Indian reserves or in Indian settlements in Québec without having to pay the fuel tax.

#### Filing an application

To apply for registration, complete this form and enclose any required supporting documents. Send the form and required documents to **one** of the following addresses:

#### Tribal councils and band-empowered entities

When applying for registration, a tribal council or band-empowered entity must provide documents proving that it qualifies as a tribal council or band-empowered entity. Examples include a copy of the band council's resolution, of the articles of incorporation or of an extract from the act

creating the council or entity. In addition, a band-empowered entity that is a legal person must provide a document attesting that the fuel purchased will be used for band management activities.

#### Providing the required information

If you do not provide us with the applicant's address or if the address is not valid, your application will not be processed. Moreover, failure to provide us with all required information and documents may cause your application to be denied or delay the issuance of your registration card.

#### Requesting modifications and other requests

If you wish to modify registration information, apply for an additional registration card, or have a registration card cancelled or replaced, complete form CA-1002.M-V, *Request to Modify Registration Information or to Replace an Attestation d'Inscription issued to a Band Council, Tribal Council or Band-Empowered Entity*.

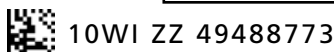
