Complete this form if you represent a person alone or jointly in dealings with us and you are acting as:

- a liquidator of a succession;
- a curator of a person unable to administer their property;
- a tutor of a minor or a person unable to administer their property; or
- a mandatary, subject to the terms of a mandate (whether or not a protection mandate) or power of attorney, of a person who is either able or unable to administer their property.

The **only purpose** of this form is to provide us with information about the representative(s) and, if there is more than one representative (see Part 2), to designate a principal representative to whom we can send all **correspondence** addressed to the represented person. This form is not a mandate or a power of attorney. If the represented person wants to

authorize a representative to access their confidential information or documents or to access their file and act on their behalf in dealings with us, the person must complete form MR-69-V, *Authorization to Communicate Information or Power of Attorney*.

Documents to enclose

Enclose any document not yet submitted that establishes the capacity in which you and any other representatives are acting. You must also enclose the documents listed below depending on the capacity of each representative.

Liquidator of a succession

In all cases, enclose a copy of the following:

- proof of death of the represented person (act of death, death certificate or burial or cremation document);
- will search certificates issued by the Chambre des notaires du Québec and the Barreau du Québec;
- proof of the last will and testament, in the form of a complete and signed copy of one of the following:
 - a notarial will,
 - a holograph will (a handwritten will) or a will made in the presence of witnesses, accompanied by a certified copy of the judgment probating the will or the minutes of the probate,
 - a notarial codicil (modification to the last will),
 - a holograph codicil or a codicil made in the presence of witnesses, accompanied by a certified copy of the judgment probating the codicil or the minutes of the probate,
 - a marriage or civil union contract.

Also enclose any document designating the liquidator (such as form LM-14.1-V, *Designation of a Liquidator by the Heirs*) in the following cases:

- No testamentary documents were found.
- No liquidator has been designated.
- The designated liquidator will not or cannot fulfill their duties.

If a person designated as a liquidator of a succession has refused or is unable to act in such a capacity, has resigned from their duties or has died, submit a copy of a document to that effect. Also provide a document naming a new liquidator, if necessary.

Make sure the documents you send us are clear, legible and of good quality. Do not send the originals—they will not be returned to you. Keep them in case we ask for them.

Curator

Enclose a certified true copy of the judgment authorizing the representative to act as a curator.

Tutor

If the representative is the tutor:

- of a person of full age who is unable to administer their own property, enclose a certified copy of the judgment authorizing the representative to act as a tutor;
- of their child who is a minor, enclose a certified copy of the child's birth certificate showing the names of the parents;
- of a child who is a minor for whom the representative was appointed the tutor by the mother or father or by the court, enclose:
 - a certified copy of the judgment authorizing the representative to act as the tutor,
 - any other document (will, protection mandate, declaration filed with the Public Curator) appointing the representative as the tutor and, if applicable, a certified copy of the probate judgment or of the minutes of the probate (in the case of a holograph will or a will made in the presence of witnesses) or of the homologation by the court (in the case of a protection mandate).

Mandatory

If the representative is the mandatory:

- of a person who is unable to administer their own property, enclose the protection mandate for the represented person, accompanied by a certified true copy of the homologation by the court;
- of a person able to administer their own property, enclose an original or certified true copy of the power of attorney or mandate authorizing the representative to act in this capacity.
