

## Designation of a Liquidator by the Heirs

This form is for heirs who want to designate a liquidator to settle the succession of a deceased person.

If a person dies and there is no testamentary provision designating a liquidator, or if the designated liquidator cannot fulfil that office because he or she dies, refuses or is unable to act, or resigns, the office of liquidator then devolves to the heirs, unless the majority of the heirs designate a liquidator of the succession.

Note that if the heirs designate a liquidator, all the heirs are considered to have accepted the succession of the deceased person. Each heir is then personally liable for paying part or all of the succession's debts. In addition, none of the heirs will be able to renounce the succession. Each heir should therefore consult a legal advisor (notary or lawyer) to make sure that he or she understands all the legal ramifications of designating a liquidator in Part 3.
