

## Election to Participate in the Québec Pension Plan: Indian Employees Whose Employment Is Excepted by Reason of a Tax Exemption

You must complete this form if you are an employer and you elect to have **all** your Indian employees resident in Canada participate in the Québec Pension Plan (QPP) in respect of employment in Québec that is excepted from the QPP by reason of a tax exemption. The employment in question is employment that gives entitlement to a deduction for employment income situated on a reserve or premises.

To make the election, complete Parts 1, 2 and 3 below. Then transmit the form, together with a resolution of the board of directors or any other document proving that the person who signs this form is authorized to do so, to the office of Revenu Québec that handles your account:

In order for the *Act respecting the Québec Pension Plan* to apply to the employment in question, the following conditions must be met:

- You must elect by means of this form to have the employment in Québec of **all** your Indian employees resident in Canada (that is, employment excepted from the QPP by reason of a tax exemption) become subject to the *Act respecting the Québec Pension Plan* as of the date indicated in Part 2 of this form.
- The date indicated in Part 2 of this form must be after June 30, 2006, but not before the date on which the form is filed with Revenu Québec.
- You must give an undertaking on this form to comply with the *Act respecting the Québec Pension Plan* and its regulations (refer to Part 2 below).

You will subsequently receive a copy of this form certifying that Revenu Québec has received your election.

Once it has been made, **this election is irrevocable.**

In addition, I undertake to comply with the *Act respecting the Québec Pension Plan* and its regulations. In particular, I undertake to

- withhold QPP contributions for each of my Indian employees resident in Canada in respect of employment covered by this election, and remit the amounts withheld to Revenu Québec, along with my employer QPP contributions in respect of that employment, according to my remittance frequency; and
- file the annual return referred to in section 11 of the *Regulation respecting contributions to the Québec Pension Plan*.
