

Childcare Expenses Qualifying for the Tax Credit Fees and Number of Days of Care for **2023**

Use this form if you are applying for advance payments of the tax credit for childcare expenses (form TPZ-1029.8.F-V) or filing a notice of change in situation (form TPZ-1029.8.F.C-V). It confirms the fees and the number of days of care for 2023. Have each person who provides the childcare services (or the person's representative) complete a separate copy of the form.

This form cannot be sent alone. It must be attached to form TPZ-1029.8.F-V or, if applicable, form TPZ-1029.8.F.C-V.

Any natural person who provides childcare, in return for payment, to a child who has not been admitted to school must get a permit from the Ministère de la Famille or be recognized by a home childcare coordinating office, unless the person is an own-account worker and provides childcare to:

- up to six children in a private residence where childcare was already being provided on September 1, 2022; or
- up to two children, or only to children who ordinarily live together, in a private residence where childcare was not already being provided on September 1, 2022.

Any person who provides childcare without the required permit or recognition is providing such services illegally. Other exceptions are described in the *Educational Childcare Act*.

1. Do not enter the reduced contribution set by the government.
 2. If the child starts kindergarten in 2023, include **only** the days on which you provided the child with childcare services.
